Message from the Chairman

Colleagues,

The tragic and surreal aftermath of the Boston Marathon bombing cast a spotlight on the character and resilience of the Boston community. Through these horrible events, we saw the best and the worst of the human spirit. I am so proud to be a part of a community and a medical center that responded to the needs of the victims and their families with such expertise, compassion, and generosity. Although the impact of this experience serves to put our daily activities in a different perspective, the critical work of our department moves forward with great energy and enthusiasm.

Several key recruitments have been completed and an important review of our administrative operations has been completed. Recently, Alice Jacobs, M.D., Professor of Cardiology accepted the position of Vice Chair for Clinical Affairs. Dr. Jacobs is a widely respected leader in cardiology and will bring great energy and skill to her new role. Eva Greenwood, M.B.A. has been appointed to the role of Vice Chair for Finance and Administration. Ms. Greenwood has been serving in the role on a part-time, interim basis since November 2012. We will be reviewing the recommendations with faculty and staff over the next several weeks to help prioritize our next steps.

Finally, I should also acknowledge the very hard work of section chiefs, section administrators, and department finance staff in successfully formulating the AY 14 budget. I am very excited about working with the new departmental leadership and look forward to further discussions about how we can improve our administrative support functions in the department.

Department of Medicine Newsletter

Alice Jacobs, M.D. has accepted the position of Vice Chair for Clinical Affairs in the Department of Medicine starting July 1, 2013. Dr. Jacobs is Professor of Medicine in the Section of Cardiology and directed the Interventional Cardiology Program in our department up until 2011.

In 2004-05, Dr. Jacobs was president of the American Heart Association (AHA). She has been a member of numerous committees and Task Forces within the national, regional and local AHA and president of the AHA Northeast Affiliate in 2002-03. Dr. Jacobs is the immediate-past chair of the American College of Cardiology (ACC)/AHA Task Force on Practice Guidelines and a member of several ACC committees. In 2011, she was president of the Association of University Cardiologists and currently serves as chair of the American Board of Internal Medicine Interventional Cardiology Self-Assessment Test Committee and as a member of the New York State Cardiac Advisory Committee and CMS MEDCAC. She has also been a member of several ACC and AHA writing groups including establishing training criteria in interventional cardiology; assessing and maintaining competence in interventional cardiology; incorporating cost and value into guidelines and performance measures; and evaluating the impact of state legislation on registry participation and systems of care implementation. Dr. Jacobs has led the AHA's Mission: Lifeline, a community-based, national initiative to develop systems of care for ST-segment elevation myocardial infarction (STEMI) patients and to increase the number of patients with timely access to primary percutaneous coronary intervention. Her major research interest is in coronary revascularization strategies. Dr. Jacobs is the principal investigator of the MASS COMM trial which is evaluating the safety and effectiveness of coronary angioplasty performed in community hospitals without on-site cardiac surgery in Massachusetts. She is also interested in cardiovascular disease in women and the sex-based differences in the epidemiology, diagnosis, treatment and prognosis of ischemic heart disease.

Dr. Jacobs is known throughout our department as a "go to" clinician and as a thoughtful and generous colleague. As Vice Chair for Clinical Affairs, she will have oversight of all aspects of our department's inpatient and outpatient clinical programs.

We are very fortunate to have Dr. Jacobs remarkable leadership of our clinical programs as we work collectively to further increase the value of our clinical services

Eva Greenwood, M.B.A. has accepted our offer to become Vice Chair, Finance and Administration, Department of Medicine effective immediately. Ms. Greenwood has extensive experience in finance and operations in local health care institutions and insurance companies. She served as Director of Finance for the Faculty Practice Foundation at BMC/BUSM from 2009-12. She has been generously serving part-time in the interim role of Chief Administrative Officer for our department since November, 2012. During this period, she has made a number of improvements in our administrative operations and established highly professional and productive working relationships with members of the department, BMC, and BUSM. She is a remarkably diligent, thoughtful leader who has a very strong commitment to the department's success in all of our missions.

I hope you will join with me in congratulating Ms. Greenwood on this appointment and welcome her to this exciting new role.
